PRESIDENT'S MESSAGE

hank you sun city residents. Twice in the last 45 days the residents of Sun City banded together as a community, and made a positive impact on the wellbeing of our community. First, when a rash of burglaries began in our community, we stuck together and became very vigilant. Metro met with our Administration, Board Members and Security Patrol and together implemented a plan that Metro suggested. Metro saturated our community with undercover officers and vehicles. Under the direction of Metro, Security Patrol added 12 two-hour shifts to do surveillance at locations suggested by Metro. Lastly, and perhaps most importantly the residents, yes YOU, became involved. You were asked to report suspicious vehicles, activities or persons and you did. This positive action on the part of our community has led to several arrests with perhaps more to come. Now these good habits that we have had for the last two or three months we need to continue. Continue to look for vehicles or behavior that is unusual or out of place in our community and report it. If you suspect that a crime is in progress, please call 911 immediately. If the criminal activity is over and you just need to report the incident call 311 and/or Security Patrol. The theft of catalytic converters has become the newest crime wave to hit Las Vegas. Vehicles that are left outside, either in the street or driveway are most susceptible. Please, if you must leave your vehicle parked outside do not leave anything of value in the vehicle. Especially do not leave your garage door opener in the car. Metro has asked that as many people as possible have cameras installed that face outward, toward the street. Having a hard drive that films and saves the images is very helpful to Metro in apprehending criminals and then prosecuting them.

Secondly, you our residents, when asked, overwhelmed our elected officials with emails and phone calls regarding SB 186. This bill as it was written would have limited communications to you our residents to mail only. I am over simplifying a bit but that was the end result. An HOA with 7781 homes needs to communicate more guickly and more effectively than sending letters. We have four community centers, three golf courses, five swimming pools, 80 clubs and community organizations as well as a community theatre. We need to communicate faster and more effectively than via mail for many items. Being a "selfmanaged" community, we need to notify our residents of committee meetings and the agendas of those meetings as well as for the last 19 months how to attend those meetings via zoom or on a limited basis "in person". Our Administration and staff can send as many as 10 email blasts every day in an effort to keep the community informed. We realize and wholeheartedly agree that certain communications such as ballots, budgets etc. must and should be sent via mail to strive to notify all residents of the business activities of the community. Legal notifications would fall in the category of mail, as well. The state of Nevada has suspended the implementation of SB 186 for 120 days so that it can now analyze the effect that it would actually have on HOA members. Again, thanks to the hundreds of you that emailed

and called our elected representatives. You were the reason that they are taking another look at this overbearing legislation.

Lastly, please continue to wear your masks and please do not argue with the monitors or other residents who might be reminding you to put your mask on or pull it up over your nose. No one likes wearing a mask BUT your Board has for the last 19 months

said that it will follow the guidelines set by health and elected officials. Monitors and your fellow residents are just asking you to follow the rules that have been set to protect to the greatest extent possible us. Be Kind Be healthy. Be friendly to each other. Be thoughtful of each other.

Changes Are Coming to the Link Magazine

The LINK team has been working hard over the past couple of months to evaluate the production of our magazine. The goal has been to make it more efficient from a production standpoint, timelier in its delivery to the community, more useful to our residents, and more cost effective. To that end, you will see some noteworthy changes in future issues.

First and foremost, it will no longer be delivered in a clear plastic envelope. Using a clear plastic envelope causes a significant delay in getting the product to the post office. We anticipate that as much as two days will be gained by eliminating the need for inserting into an envelope. Instead, the magazine will be delivered just like many other magazines, as a stand-alone piece of mail. By utilizing the US Post Office Every Door Delivery, we hope to gain another couple of days in arriving at your mailbox. And we will realize a significant savings in postage.

Secondly, the section of the magazine which contains official Sun City notices and information, casually called the "blue pages", will be produced differently from the rest of the magazine. Rather than printing these in full color on heavy glossy paper, we will simply produce them with black ink on blue bond stock. This saves costs, allows for more full color pages, and increases editorial and advertising pages. It will also allow residents to retain the blue pages with their other community document if so desired.

You will no longer see loose inserts with the magazine. Everything will come as one complete piece. We feel that these changes will provide multiple benefits to our community. As always, we do appreciate your feedback.





HEALTH & FITNESS Balancing Matters

or November, the Health & Fitness Department will continue to focus on the importance of balance and fall prevention. We will also be bringing back our in-person healthy cooking demo this month where we will look at "wellbalanced" meals.

Your sense of balance comes from many different systems in the body that work together to create stability. Good balance depends on your eyes, your muscles, tendons, and joints, and your inner ear.

Putting It All Together

1. Visual System - Your vision helps you see where your head and body are in relationship to the world around you and to sense motion between you and your environment.

2. Proprioceptive Input – Special sensors sensitive to stretch or pressure in your muscles, tendons, and joints help your brain to know how your feet and legs are positioned compared to the ground and how your head is positioned compared to your chest and shoulders.

3. Vestibular System- Balance organs in the inner ear tell the brain about the movements and position of your head. They tell the brain when the head is moving in a straight line and sense the position of the head even when it is still.

Information from your vision, muscles, tendons, joints, and balance organs in your inner ear are all sent to the brain stem. Your brain can control balance by using the information that is most important for a particular situation. – American Physical Therapy Association

Fall Prevention

As we age, fear of falling can sometimes consume us. Some people worry about falling, and the consequences of a fall, even if they've not yet fallen. Or if you have experienced a fall, the anxiety increases and the physical activity decreases causing a vicious cycle.

How to deal with anxiety about falling?

- Keep Active.
 - Make a plan for getting help if you should fall.

- Talk to someone about your fears and anxiety about falling.
- Set small achievable goals to help you feel more confident again.

• Practice relaxation techniques.

If you've had a fall, ask yourself:

- Were you in a hurry?
- Was the floor cluttered or slippery?
- Were you using the correct walking aid if you use one?
- Were you feeling dizzy?

If the goal is to age in place and live independently as long as possible, balance and fall prevention are extremely important topics for older adults. The concern is real and must not be overlooked. Your health and well-being are multi-faceted and staying balanced in your mind and body are key. 

The POWER of GRATITUDE and THANKSGIVING

any of us have heard that if we have an "attitude of gratitude" our quality of life can be better. Is there any truth to this? Have you ever wondered if being grateful and being thankful are one in the same? Given that we have so much uncertainty in the world, can we be truly grateful? As we begin the holiday season with Thanksgiving Day, it might be interesting to take a deeper look at the power of gratitude and thanksgiving, and what it can do for us.

Six different research studies were reviewed to examine what has been discovered thus far. Fr. Stavros Akrotirianakis, from the Orthodox Christian Network, wrote that he felt gratitude to be more of a feeling, while viewing thanksgiving as an action. In other words, one can feel grateful for something that's been done on that person's behalf but without the action of giving thanks. However, one cannot give thanks without feeling grateful; thankfulness is gratitude in action.

According to research from Harvard University, there is a strong connection between consistent gratitude and greater happiness. People who express gratitude also appear to have more positive emotions, savoring the good experiences in their lives; building up stronger relationships and dealing better with adversity. Whether being grateful for the past such as childhood blessings, grateful for the present by not taking good things that happen for granted, or looking forward to the future with hope and optimism, the researchers found that gratitude can be cultivated.

Three different studies have shown that subjects that wrote

about things they were grateful for each day felt their lives were more fulfilled, exercised more, and saw fewer doctors than those who focused on aggravations. Other studies have shown that couples who express gratitude for each other not only feel closer to their partners but also feel freer and more comfortable expressing problems that might affect their relationship.

In one experiment, random people on the street were given flyers that either read "Life is unpredictable. Stop and smell the roses." or "Life is constant. Stop and smell the roses." A few feet away was a table with roses on it. Researchers found that subjects that had received the "Life is unpredictable, stop and smell the roses" flyer had stopped 2.5 times more than those who received the other flyer.

Other studies found similar results; subjects were more likely to savor their lives in times of uncertainty. These studies suggest that, especially now in the current pandemic and other changes happening in this world, the upside is that more people are grateful and more appreciative of the simpler things in life.

Of course, much of the evidence has been empirical; it's hard to truly measure feelings except through observation and documentation, but the vast majority of the evidence suggests gratitude is a powerful emotion and giving thanks amplifies one's positive feelings.

So, in the beginning of this holiday season, where perhaps we can all benefit from cultivating more gratitude, Dr. Robert Emmons, considered the world's leading expert on gratitude, offers these suggestions:

- Keep a gratitude journal, not only of events and people of the day that one is grateful for but also gratitude for one's own attributes;
- Remember the bad: when you relive troubling events and make a contrast to how far you've come, it helps one to be grateful;
- Ask yourself three questions, utilizing a meditation technique known as Naikan, which involves reflection: 1) what have I received from ____? 2) What have I given to ___? and 3) what troubles and difficulty have I caused?
- Learn prayers of gratitude. In many religions these prayers are considered the most powerful.
- Come to your senses. That is, recognize and appreciate the senses of the body and how miraculous it is that we can see, hear, taste, smell and touch.
- Use visual reminders. Forgetfulness and lack of mindful awareness are two obstacles that contribute to lack of gratitude; visual reminders, especially of other people, can help.
- Make a vow to practice gratitude every day. A simple note to yourself posted where you will see it is enough, and everyday action creates a good habit.
- Watch your language. Focusing on what others have done

for you using words like blessing, abundance, good fortune, kindness, etc. are powerful positive words.

- Go through the motions smiling, thanking people, or writing thank you notes encourages gratitude.
- Think outside the box. Look for creative ways to express your gratitude.

The benefits of gratitude and expressing thanks cannot be denied; improvements in health, both physical and mental, and overall quality of life have been clearly proven.

For myself, I have decided to name five things I'm grateful for that have happened during the day, no matter how small, every night as I fall asleep. I can assure you I have already felt the benefits.

And so, as we enter into that time of the year of so much joy but also stress, I'd like to leave you with this prayer of gratitude:

"People are often unreasonable and self-centered. Forgive them anyway. If you are kind, people may accuse you of ulterior motives. Be kind anyway. If you are honest, people may cheat you. Be honest anyway. If you find happiness, people may be jealous. Be happy anyway. The good you do today may be forgotten tomorrow. Do good anyway. Give the world the best you have and it may never be enough. Give your best anyway. For you see, in the end, it is between you and God. It was never between you and them anyway." - Mother Theresa

Jerry Takier in Vietnam. **CAPTAIN JERRY TAKIER**

n 1961 Jerry Takier, who was just out of high school, joined the Army. That same year the first 400 Green Berets were positioned in Vietnam. Their mission: To train and advise the South Vietnamese troops to fight the North Vietnamese Army (NVA). At that time the Cold War with Russia was raging, but Jerry's first job as an enlisted man was not in a combat unit, rather his duties were working as a company finance clerk. In time he advanced to be a payroll specialist.

By 1965 he progressed to be a sergeant, his four-year enlistment was up, but instead of returning to civilian life he accepted a spot in Officer Candidate School and re-enlisted. After spending six months at Fort Benning he graduated as a Second Lieutenant in July 1966. By December he was leading an infantry platoon in Vietnam.

Troop strength was rapidly increasing and, by December 1966, 385,000 US soldiers were deployed in Vietnam. Lieutenant Jerry Takier was stationed about 45 miles Northwest of Saigon near the Cambodian Border at Dau Tieng base camp. The NVA and Viet Cong (VC) in the area fought using the Cu Chi Tunnels, which they would disappear into.

Jerry recalls, "Tactics changed from prior wars when uniformed soldiers fought in battalions. In Vietnam the enemy was underground, beside us, and not in a uniform. Skirmishes occurred. We were attacked, fired upon and shelled with mortars one minute and the next the enemy would disappear

into the tunnels. You also never knew if a grandmother, or a child, would toss a hand grenade - In 1967 the US mission was basically to reduce the effectiveness of the NVA / Viet Cong and give the South Vietnamese the time to politically take charge, but that never happened".

Life in the infantry was hard. "We were loaded down like pack mules and had to hack our way through jungles." From February until May 1967 Jerry participated in "Operation Junction City", a joint infantry and airborne mission where helicopters were used to find, push, and corral the Viet Cong in an entrapment area where his, and other, infantry units would be waiting.

During this time the NVA / Viet Cong suffered many more casualties than the US and South Vietnamese forces and the "loss casualty ratio" was favorable. At the time this was considered a winning strategy. However, the Viet Cong were fighting a querrilla war and many escaped into underground tunnels, only to fight another day. These types of pincer operations continued throughout 1967. Jerry returned stateside in December 1967, fortunately missing the February 1968 Tet Offensive, which was a major turning point in the war.

With three years left on his commitment he knew a second tour in Nam was in the cards. The thought of returning as an infantryman was not appealing. Being battle proven, and after undergoing a battery of tests, the next phase of his military career began, piloting a helicopter. Of note, during this time between tours he met, and married - Penny, who is pictured with Jerry by a Huey helicopter. Penny is a RN, but that is a story for another day.



First it was flight school at Fort Wolters in 1968 where the basics of aerodynamics were taught. After attending advanced flight training at Hunter Army Airfield in Georgia he was qualified to fly a UH-1, commonly known as a Huey.

Captain Jerry Takier returned to Vietnam early in the summer of 1970 with the First Squadron, Ninth Infantry Regiment, First Cavalry Division as a helicopter pilot. The war, and tactics, changed and a slow, strategic, retreat towards Saigon was occurring. First stationed at Phouc Vinh, his unit was pulled back to Bearcat. The plan was to gradually withdraw and return responsibility to the South Vietnamese Government.

On the ground, and in the air, the teams were divided into colors. The scouts were the white team flying OH6 Observation helicopters, slowly, at treetop level. Rotor-wash was used to part the trees while looking for the enemy. When the NVA / VC were encountered the red team, which were AH1G Cobra attack helicopters, were called in. When the red and white teams worked together they were the pink team. The blue teams flew UH-1 helicopters loaded with infantry and were called in to provide ground support when enemy action was heavy, or a chopper crashed.

Jerry flew as the blue platoon leader when first assigned but later was promoted to company commander of Headquarters and Headquarters Troop. His combat flight time was reduced during his final months in Nam. Upon returning to the states he recalled his first assignment and realized he not only had an aptitude for numbers but he also loved finance and accounting.

While continuing to serve in the military he also was a full time student at the University of Columbus in Georgia, earning a BS in business with an emphasis on accounting. But the military did not need accountants and, in 1974, the same year that the Vietnam War ended, Captain Takier resigned his commission to enter the world of finance and began working as a CPA for Ernst & Ernst.

During the next 10 years Jerry expanded his knowledge, developed a clientele, and in 1984 bought a thriving accounting practice in Arroyo Grande, California from a retiring CPA. The business grew and a second office was opened in Atascadero. Jerry sold his business and retired in 2016.

In 2010 Jerry began volunteering his time to help develop the Estrella Warbirds Museum and, true to form, he advanced to become the museum's President before moving to Sun City. Estrella Warbirds Museum is located in Paso Robles, just a 6 hour drive from Vegas. Anyone interested in military artifacts, aircraft, vehicles and memorabilia will enjoy this museum. Jerry and Penny Takier moved to Sun City in 2016 and he now serves our community by volunteering his time with the Security Patrol driving our streets, but unless you are up real early you probably will never see him because he usually drives the 3AM to 7AM shift.



But service is not only about one man, or what someone did in the past, service to our community transcends to the present. November 11th is Veterans Day, a time to honor all who served in the military, and just as you may never see Jerry when he patrols our streets you probably do not know the stories of service other members of the Sun City Security Patrol have accomplished in their lives. Some members of the Security Patrol who have previously been in the military are pictured outside of the Security Patrol office located at the far end of the Desert Vista parking lot. Members of our Security Patrol keep our streets safe and continually serve our community. But our Security Patrol constantly needs new recruits and anyone, whether you have been in the military or not, is invited to come to the patrol's office to inquire about how you can volunteer and serve our community by joining.

Lastly, Jerry is a member of the Military and Friends club and he enjoyed the comradery the club provided but recently the club has not been able to meet. Jerry said, "Trading war stories was mentally soothing, but COVID-19 has interrupted that for more than a year". The Military and Friends Club is now mustering its forces and although our battle with COVID-19 continues the club is again meeting to provide support and fellowship for those who have served. 



"As I See It . . . "

Living in the TODAY

"Living in the present moment means letting go of the past and not waiting for the future. It means living your life consciously, aware that each moment you breathe is a gift." - Oprah Winfrey.

s much as I know there is no benefit dwelling on the past, because it is done and cannot be changed . . . as much as I know there is no benefit dwelling on the future, because it has not happened, and maybe never will happen . . . it still is difficult to let go of past hurts and things undone or to fear things that "could happen". The source of so much pain and regret is often in the past, and the source of worry and fear is very often in the future. The past is done – the future is just less than even a guess. What we have is TODAY. Question: Are we making the very best of TODAY. We are free to make that choice, we are free to pause and inhale every second of TODAY.

Living for tomorrow involves leaning on your self-control and investing time in yourself. Living for today focuses on improvements that you'll see right away. You could think of living for tomorrow as making a deposit in the "Bank of I", while living for today is making a withdrawal.

Living in the present moment means no longer worrying about what happened in the past and not fearing what will happen in the future. It means enjoying what's happening now and living for today. Choosing to live in the past or the future not only robs you of enjoyment today, but it also robs you of truly living.

Here are some ways we can "Live in the Today" —

1. Focus on the now. In order to live in the moment, you need to focus on the now. Focus on what you're doing. Shut off the TV, turn off the computer, slow down, and savor the present. Practice "mindfulness" – according to Dixit, living for the moment by practicing mindfulness reduces stress, boosts your immune system, lowers blood pressure, and has other beneficial physical and mental effects. Jay Dixit, senior editor of Psychology Today, adds that mindful people are more secure, have higher self-esteem and are happier.

2. Pay attention to the small things. Notice the world around you: the small things. Be thankful for them. Living for the moment and taking notice of the small things will help you


cultivate more positive experiences. Cheryl Rainfield, an artist and writer, recommends you pay attention to the little things that make you happy, like eating ice cream, blowing bubbles, or listening to music, as these things can make a huge difference in how you feel.

3. Smile. If you want to know how to live in the moment, you just have to take a look in the mirror and smile. Smile – it can influence how you feel. Scientific American Mind magazine reports that making an emotional face influences how we feel. If we feel happy, we smile. If we smile, it makes us feel happy. So smile – it will make you happier and help you appreciate life in the moment.

4. Perform random acts of kindness. Random acts of kindness, those selfless acts that help others, help you live for the moment of making others smile, and making you smile as well. Random acts of kindness are just that — random. They are spontaneous, in the moment, and a great addition to your daily life. The next time you see that person walking in the rain, offer them your umbrella. That stranded motorist? Call for help. The elderly lady struggling with her groceries? Carry them for her. One of the easiest lessons for how to live in the moment is to do something for someone else without expecting anything in return. It not only helps you live in the moment, but improves that moment for you and someone else.

5. Give thanks. Be thankful. Sounds easy, doesn't it? But it isn't always. It doesn't have to be Thanksgiving for you to feel grateful and express that gratitude. Every now and then, remember to stop and take stock of just how good you have it. When your friend makes you smile, thank her for being in your life. When you think it or feel it, say it right then. Live in the moment by expressing your gratitude when you feel it.

6. Don't worry. It's much harder than it sounds, but try to remember that worrying today won't change what happens tomorrow. Every second you spend in worry about the future is a second of the present wasted. Because worrying takes you out of this moment and transports you into the realm of future possibilities, it's impossible to live in the moment and worry at the same time. Instead, if circumstances are troubling, focus on ways you can solve an existing problem now or otherwise improve the current moment. Spending time focused on what may happen down the line robs you of fully experiencing what is happening now. Life in the moment moves quickly — don't miss it.

A motion was approved that the executive board has determined by this motion to use the "duly elected process" for the 2022 executive board election as allowed by NRS 116.31034 Paragraphs 5 and 6 which states among other things that, if, at the closing period for nominations, the number of candidates is equal to or less than the number of vacancies, then (a) the Association will not prepare or mail any ballots and (b) the nominated candidates shall be deemed to be duly elected to the executive board at the meeting of the unit's owners at which ballots would have been opened and counted. 5. Membership Meeting: The Budget Ratification meeting is a Membership Meeting. Per the Sun City Summerlin Community Association, Inc. Bylaws.

(1) All meetings of the membership of the Association shall be held at such location within Sun City Summerlin or elsewhere, within Clark County, Nevada as the Board shall determine. Due to the COVID-19 Pandemic the Membership Meeting will be held via Zoom. Due to the Governors Directive and an effort to protect the health of our Owners and Employees, the meeting room is closed to non-Board members. Zoom is a cloud based video conferencing service that allows you to connect through your smart phone, computer or tablet using a webcam or if you prefer by just calling in on your mobile or landline phone. Directions on how to join this meeting are included in this packet.

There shall be one (1) vote for each lot owned, subject to the authority of the Board of Directors to suspend the voting rights of the owner for violation of the Governing Documents or for failure to pay a fine or a duly adopted assessment. For each lot owned you will receive one ballot at the address you have designated for Association mailings.

The budget is deemed ratified, unless at that meeting, a majority of all unit owners reject the budget. Due to the COVID-19 Pandemic total attendance and majority of unit owners at this meeting will be determined by the number of absentee ballots returned. For the fiscal year ending June 30, 2021 there is no change in the assessment amount, however the allocation of the assessment has changed. If the proposed budget is rejected, the periodic budget last ratified by the unit owners must be continued until such time as the unit owners ratify a subsequent budget proposed by the Executive Board per NRS 116.31151(3). Due to the COVID-19 Pandemic the Board of Directors, Finance Committee and Staff have worked hard to make sure that enough funds will be available in the operating fund to meet the normal operating expenses of the Association and to take care of the additional cleaning, disinfecting and social distancing needs to meet the State of Nevada Directives and reasonable expectations of the Members of the association, without raising the annual assessment. However, if the Owners do not vote yes to ratify the budget, then we will have to operate on the 2020 fiscal year budget, while this is the same annual amount, the allocations to Reserves, New Capital and Operating are not the same and the 2020 fiscal year budget will not meet the Operating needs of the Association in the 2021 fiscal year.

2020 INFORMATION - CORRECTED IN OCTOBER 2021 CORRECTIONS IN RED

The proposed annual dues for the fiscal year 2021 beginning July 1, 2020 and ending June 30, 2021 will remain at \$1,647.00. Of this amount, \$26.00 will be a contribution to the reserve funds, \$75.00 will be the contribution to new capital assets, and the remaining \$1,546.00 will be used for operations.

The Board of Directors has put a freeze on hiring and on wages from thru December 31, 2020 and has put a hold on all non-essential spending from the Reserve Fund for the fiscal year ending June 30, 2021, Only essential items will be replaced, and then only if required. Essential items are items such as air conditioners, water heaters, pool equipment, pumps, etc.

Per NRS 116.31151(2) & (4): The current reserve study on file was prepared for the fiscal year ending June 30, 2020 and was conducted by Complex Solutions. Complex Solutions is a licensed reserve specialist with the state of Nevada. The Reserve Study was prepared by compiling significant components (assets), assigning each a useful life, a remaining life and a dollar amount to replace the item.

Per the Reverse Study, the estimated amount needed for the Reserve Fund to be fully funded on July 1, 2020 would be \$19,519,730.00, to repair, replace or restore all the major components of the common elements that the Association is obligated to maintain, repair, replace or restore. We estimate that the beginning balance in the Reserve Fund will be \$12,815,000.00 on July 1, 2020 or 66% funded.

Per the Reverse Study, the estimated amount needed for the Reserve Fund to be fully funded on July 1, 2021 would be \$18,076,008.00 to repair, replace or restore all the major components of the common elements that the Association is obligated to maintain, repair, replace or restore. We estimate that the beginning balance in the Reserve Fund will be \$13,732,306.00 on July 1, 2021 or 76% funded. The Board has approved a 75% funding level as a goal for reserves.

The Board of Directors have determined that it does *not* anticipate the levy of one or more special assessments to repair, replace, or restore any major component of the Reserves.

2020 INFORMATION CORRECTED IN OCTOBER 2021-CORRECTIONS IN RED Sun City Summerlin Community Association, Inc.

Each year, as required by Nevada Revised Statue (NRS) 116, and our own governing documents, SCSCAI Homeowners are asked to ratify a proposed budget for the upcoming year. The SCSCAI Master Bylaws on page 12 state that the Board will "Distribute a summary of the budget for each fiscal year to the membership not less than thirty (30) days or more than sixty (60) days before the beginning of the fiscal year. Copies of the full budget are available at the Association's offices for copying, said budget to include at least the following information: "

The budget preparation begins in January with the Executive Director and the rest of the SCSCAI Staff preparing their budget needs for the next fiscal year. In March, we hold a series of budget workshops, open to all members, where the Department Managers explain their proposed budgets, questions are answered, and changes made as needed. The next step is for the Finance Committee to review the Proposed Budget. After reviewing the budget with the SCSCAI Department Heads, the Finance Committee then votes on the Proposed Budget with any recommended changes and recommends a budget to the SCSCAI Board of Directors. The Finance Committee recommendation includes the proposed assessment rate to support the Proposed Budget. The Board then votes on a Proposed Budget and that budget is sent to the homeowners for consideration.

This year the budget preparation process was much more difficult. We had a Proposed Budget pretty much final in March, but had to start over because of the impact of the COVID-19 on our budget. For example: how was the pandemic going to impact the cost of operating our restaurants and what will be our revenue; how will the pandemic affect the Starbright Theater cost and revenue; and how will the pandemic affect the cost of maintaining our facilities. In a series of Board meetings and workshops, thanks to yeoman efforts by the SCSCAI Staff, we essentially did a complete redo of the budget in about a month's time. What was sent to you, our Homeowners, reflects the Board's best estimate of our budget needs for the next budget year, July 1, 2020, thru June 30, 2021.

When the Board began reworking the entire budget after the onset of the COVID-19 pandemic, two things became apparent. First, flexibility in spending so that the Association could deal adequately with the unknown expenditures and loss of revenue. Secondly, control expenses without increasing assessments to the members. The Board determined that except for emergency repairs or replacements, the reserve fund and capital expenditures would have to be put on hold. Also, the Board instituted a pay freeze and a hiring freeze. The Budget now being presented to the members allocates more funds to operating expenses. This will allow the flexibility to move employees to areas of operation where they may be needed to help clean and disinfect. Also substantially more money needed to be allocated to cleaning products and equipment to aid staff when a gradual reopening would commence. This Proposed Budget allows for the flexibility that will be needed to act and react to the pandemic-related expenses that will occur in the next budget year.

The next step in the budget process is for you, the homeowners, to consider the budget. In past years, we held a meeting where the budget was voted on by any members who attended. Per NRS116, "Unless at that meeting a majority of all units' owners, or any larger vote specified in the declaration, reject the Proposed Budget, the Proposed Budget is ratified, whether or not a quorum is present. If the Proposed Budget is rejected, the periodic budget last ratified by the units' owners must be continued until such time as the units' owners ratify a subsequent budget proposed by the Executive Board." Because of the prohibition by the State of Nevada on large gatherings, we cannot hold a budget ratification meeting so this year we are sending out a mailin ballot asking our Homeowners to ratify the Proposed Budget.

The Board of Directors, the Finance Committee, and the Executive Director urge your approval of the Proposed Budget. As you can tell from the paragraphs above, an incredible amount of work was done on preparing this year's budget. What is so near and dear to your wallet, the assessment stays the same as it was for the previous year, no increase in the assessment. We were able to maintain essential services and amenities despite having to factor in the cost of the pandemic. Should the budget be rejected, we revert back to the present fiscal year's budget, which as you can imagine, does not reflect the reality of the fiscal needs for the next budget year.

In summary, please vote for the ratification of the Proposed Budget. The budget was vetted by a very talented Finance Committee that included several CPA's who donate their time and talent to insuring SCSCAI maintains a strong fiscal position. Homeowners had many opportunities to question any aspect of the budget, and indeed did; therefore, the budget is much better because of their comments. Finally, your Board of Directors spent many, many hours going over each and every line item in the budget to make sure each item was needed and budgeted appropriately. Vote YES for the proposed July 1, 2020 thru June 30, 2021 budget.




