
# PRESIDENT'S MESSAGE

ummer is winding down and the "monsoons" are over. We still need to keep ourselves hydrated as the temperatures are still very hot. Once again, we need to keep an eye on each other and if we see a friend, neighbor or anyone that looks like they need to be hydrated we should make sure that they get water.

On the subject of looking out for each other, who has checked their Emergency Contact forms lately? We all should have a CURRENT Emergency Contact form on file with Administration and the Security Patrol. We all filled one out back when we moved in and may even have updated the information at some point in time. This information is critical if an emergency occurs inside or outside of your home. Security Patrol is asked to do "Welfare Checks" on residents quite often. If information about family members and/or close friends or neighbors is readily available, then a rapid resolution of many issues is possible. It is always best to have a local contact as well as a relative or two listed. Metro has its protocols when asked to do a "Welfare Check" as well and they often ask Security Patrol for contact information about family or anyone that might have a key or a code that would allow a more rapid entry into a home. I am not suggesting that you give a key or a code to just anyone BUT if you have a trusted friend or neighbor perhaps you can share this with them and get their permission to list them on the Emergency Contact form providing their contact information as well. The blue Emergency Contact forms can be obtained from Administration, all Information Centers, any Security Patrol car, or at Security Patrol base (located in the rear of Desert Vista parking lot). Please check to make sure that your information for your contacts is current. Often, the people that you listed years ago have moved or are otherwise not available to help anymore. All information is confidential and only used in situations that demand that someone be contacted whom could help you.

We should all try to be good neighbors. It is one of the greatest strengths of our community. Being a good neighbor might be bringing in your neighbors' trash cans, letting them use your name on the Emergency Contact sheet, watching their house when they are gone or just saying "hi" to them whenever you see them. Start a Neighborhood Watch program on your block and walk around to meet and sign up your neighbors to participate. Our goal is to have over a hundred Block Watch Captains. As everyone knows, security within our community is a priority of the Board of Directors and it has approved major expenditures to add more and more cameras in the community.

All of us can help Metro by not only being vigilant but having cameras on our homes. Two of the most recent crimes committed in our community were resolved by cameras. In both instances it was a neighbor's camera that captured a picture of the criminal that led to their arrest. Metro can enhance images on our cameras so well that they can identify people

and vehicles that are suspicious or may have been used in the commission of a crime. If you invest in security cameras, please purchase the kind that store the images forever. At least one of the cameras should be pointed towards the street.

One last suggestion: Do not talk with strangers about where you live, what valuables or guns you might have or when you will

> be out of town. The criminals scour social media to find out if you are on vacation or not home. Talking to strangers in the casino and sharing this type of information is also a very bad idea. Keep your personal information private. Be Safe, Be Neighborly, Be Kind,

Be Vigilant but most of all Be Happy.

#### EMBERING SEPTEMBER 11 2

We all remember where we were on September 11, 2001, and the disbelief we felt as we watched the events unfold on television, but do you remember the day you quit thinking about what happened that day every day? Do you remember when you guit being afraid? Quit crying? For just a few moments, take some time to remember September 11, 2001, and how as individuals we came together to help each other and to grieve for people we knew and those we had never met.

One Great Country, the United States of America joined together by tragedy on this day 21 years ago. 7,670 days have passed since that horrible day. Some have lost so much that it might as well have been vesterday.

The events of that day are now taught as history in grade school and high school. The children born after September 11, 2001, will now be turning **21** years old, and while they were not even alive at the time, the events of the day and the number of people impacted is still unbelievable to them, as they learn:

4 airplanes were hijacked by al-Qaeda. Two of the planes were flown into the twin towers of the World Trade Center in New York City, a third plane hit the Pentagon in Arlington, Virginia, and the fourth plane crashed in a field in Shanksville, Pennsylvania.

**19** terrorists from the Islamic extremist group al-Qaeda hijacked four airplanes and carried out suicide attacks against the people of the United States.

87\* people aboard American Airlines flight 11 were killed when the plane crashed into the north tower of the World Trade Center. \*This number does not include the 5 hijackers.

\*\*\*\*\*\*\*\*\*\*

60\* people aboard American Airlines flight 175 were killed when the plane crashed into the south tower of the World Trade Center. \*This number does not include the 5 hijackers.

**Bv** Mitzi Mills

2,596 people were killed in the World Trade Center and surrounding area and over 6,000 were injured.

58\* people aboard American Airlines flight 77 people were killed when the plane crashed into the Pentagon, killing an additional **125** military personnel and civilians. \*This number does not include the 5 hijackers.

40\* people aboard United Airlines flight 93 were killed when the plane crashed into a rural field near Shanksville, Pennsylvania. It is unknown what target the terrorists had for this airplane, as passengers aboard were able to stop the plan, while knowing they were going to die anyway. \*This number does not include the 4 hijackers.

People from 78 different countries died.

- 343 Firefighters and Paramedics died trying to save others.
- 23 New York City Police died trying to save others.
  - 37 Port Authority Police Officers died trying to save others.

These numbers are important, and devastating, and it is important that we never forget them, but what cannot be taught is how we felt, what we did and who the people who died really were, that is lost if those of us who experienced it do not keep the story alive. I hope we never forget what happened that day, but even more importantly I hope that it helps us remember what is important to each of us and how kindness and understanding really are sometimes the most important thing to share.

September: Healthy Aging Month Why Healthy Aging Month?





#### **On Being a Board Member**

As we approach the time of year when residents consider running for the board of directors it is appropriate to explore what it means to be on the board. **The Community Associations Institute (CAI)** has a very useful publication titled *"The Board Member Toolkit."* One of its chapters is on the Role of the Board. That chapter details what makes a strong board member and what makes an inappropriate board member. So, let's explore that a bit.

CAI says a strong board member has calm judgement, a willingness to serve, good character, relevant experience, and strong integrity. A key component is to be committed to the best interests of the community as a whole.

They go on to state an inappropriate board member is unable to put the welfare of the community first. They work behind the board to run things their own way. They are unable to work with others for the common good and have poor interpersonal skills.

It is also important to know the difference in the roles of the board and the management of the community. Boards set policy and make policy decisions. The Executive Director and their staff implement the board's directives and take care of operations. It is inappropriate for an individual director to give direction to staff, or to interfere with their job functions. Only decisions and directions made by the entire board are marching orders for staff.

Collectively, the board determines how the HOA should operate. Healthy discussion and debate are appropriate. The board

is not a rubber stamp for proposals or decisions. Divisive, accusatory, and personal comments are not helpful in determining the decisions of the board. Once items are decided and voted on, all directors should move forward together.

The role of the board is as much about building the social and civic well-being of the community as it is about maintaining common areas or enforcing rules. To do this a board must provide leadership and inspiration, not just administration. It should instill a sense of caring, civic pride, and shared responsibility for all. By placing an emphasis on community, boards transcend the legalistic nature of their governing documents. Thus, efforts to work together tend to reduce the number of administrative issues such as rule violations and assessments.

Being selected to a leadership position can give some people a false sense of importance. It is important for board members to remember that they have a serious responsibility to serve the community, not their egos. Telling a professional manager how to do their job is a waste of the manager's expertise and the association's money. It is important for boards to focus on setting policy and leave the implementation of those polices to the manager and staff.

Being a board member takes a commitment to work for the community. As is often the case, there can be a wide range of opinions and discourse from a 12,000-resident group. By following the guideline of acting in the best interest of the community, individuals who serve should be confident that they are fulfilling the responsibility they were elected for.



### Strike Plates on Door Latch

They try to get you through the phone. They try to coerce you on the internet. They try to persuade you in person! Don't get mad, get even! Just hang up the phone and if you can, block that number. Check your phone service for a way to reject those computerized calls. If you find a strange email or message from someone you do not recognize, *do not open it*! Delete that "so-and-so" as quickly as possible.

Now we come to the person that shows up at your door. Hopefully you have a sign out that says "No Trespassing" or "No Soliciting." This is a clue that there is no welcome to strangers at this home. Try to find your courage and if they do ring the doorbell or knock, tell them *through* the closed door you do not wish to speak to them and to go away. If they persist, call metro on the 911 number. Then you can call Security Patrol, we can drive by, many times that will discourage those pesky people.

A few other important points were discussed with the Crime Prevention Officer at the Metro Summerlin Area Command, Manuel Barela. Manuel says that being "situationally

> aware," in other words, take the time to be mindful of people and actions around you, your home, and your car. He emphasizes that 55% of harmful incidents could be preventable.

But What If I'm Not Home? These are other thoughts from Officer Barela, "I highly recommend looking into installing one of the many available doorbell cameras. These are great because if someone is ringing your doorbell, you can still answer the door even if you're away to give that sense of occupancy. There are also plenty of products on the market that can do things such as turn your TV on at random intervals to convey the illusion of occupancy as well. Another great product are the lights you can install at the front of your house that turn on when it gets dark and turn off when it's bright out."

By utilizing just a few of these tips, we can make our homes look far less appealing to criminals and keep us more secure. If you're interested in having Mr. Barela come out for a site survey at your home, please send him an email M14969B@lvmpd.com and he can discuss home security further!

Another tip he emphasizes – Check your door strike plate and make sure you have 3"- 4" screws securing it to the door frame. (The strike plate is the metal area where the latch and bolt go into the door frame.)

Your Emergency Contact Information (That blue sheet). Please visit the Security Patrol headquarters to make any recent changes to your information on your emergency contact sheet. Should you have a water problem or an open garage door along with any other important home situations, Security Patrol may need to contact you. It is so important to have current phone numbers and information. If you are an owner renting your unit, give us your information as well as the occupants.

**We Need You!** Security Patrol is always welcoming new recruits. We can go over the various and important jobs to see if you think any would fit your schedule. Drop in or call us at the building at the very end of Desert Vista parking lot. Phone numbers are on the side of every Security Patrol car 702-254-2303.

# THE NEIGHBORHOOD PREPAREDNESS TEAM



Do you have a Neighborhood Watch sign on your block? Do you know who your Neighborhood Watch Captain is?

n September 11, 2001, I was driving North on the New Jersey Turnpike to my job as the Medical Services Director of Newark Juvenile Detention Center which is a prison. The radio reported that a plane just hit the World Trade Center. I saw the first building burning, but the view was gone before the second plane hit.

On October 29, 2012, I was the Director of Nursing at a New Jersey nursing home when Hurricane Sandy sent a roller coaster into the Atlantic Ocean twenty miles away. No electricity for a week and the generator fails. Nurses who lived by the beach had to dig out from three-foot sand drifts, and more yet we, as a team kept almost 100 patients safe.

From these and other experiences I know that life can change in an instant and the best way to survive a crisis is to have an action plan in place before an event occurs.

On July 30, 2022, over 750 Sun City residents attended three packed presentations at the Starbright Theater when Captain Sims from Las Vegas Metro Police reassured the audience that the person who attempted to murder one of our residents is no longer in Nevada and is being pursued. Captain Sims emphasized that this was a rare event and assured us we are safe from the perpetrator. On July 31st the perpetrator was arrested.

Ensuring safety is paramount and when a resident is threatened with a gun it shakes our sense of security. But what would our community do if a major event such as e.g., an earthquake, hits Las Vegas? Is our community prepared to deal with broken water mains, burst gas lines, and no ability to communicate by phone?

This is where the Neighborhood Preparedness Team (NPT) comes in. The question is: How does NPT differ from Neighborhood Watch (NHW)?

Neighborhood Watch (NHW) is a proprietary program run by the Las Vegas Police Department that enlists block captains who organize homes that are in view of each other to watch out for suspicious activity in their specific area. ### So, how does NPT differ from Neighborhood Watch?

The Las Vegas Police Department cannot release the names of Neighborhood Watch (NHW) block captains without their permission and the NHW program is not designed to protect our entire community, rather to only guard 10 to 30 homes in a localized area. This works well in most Las Vegas neighborhoods, but Sun City is different. We, in reality, are like a small city containing over 7,800 homes.

Rather than just overseeing the security of a few homes NPT is a *"Communitywide Network designed to mitigate the consequences of natural, industrial, or criminal incidents."*

When a natural disaster, such as an earthquake occurs, it is essential to maintain communications, not only with your nextdoor neighbors, but with our entire community and this where NPT gets involved.

But earthquakes are not our only concern. What if an active shooter is firing away in our community? How do we quickly warn residents to stay in their homes and away from the area where the shooter is?

Catastrophic events rarely and hopefully never occur. But if or when they happen we must be prepared and one primary factor that saves property and lives is the ability to communicate and coordinate rescue activities. We must rely on each other to quickly organize to work together and prevent destructive paranoia, fear and rumors that disrupt and paralyze recovery efforts hampering rapid mobilization.

Neighborhood Watch (NHW) can be a crucial tool to accomplish this, but for this to occur NHW block captains must have the ability to communicate and coordinate actions and organize resources. NPT has the ability to unite Sun City's individual NHW sectors to minimize threats that impact all or a large part of our community.

Our Sun City Security Patrol is an essential piece of the puzzle and their involvement in NPT is vital. If telephone communication is disrupted the watch commander has the ability to communicate with our security patrol cars.

NPT's Amateur Radio Subcommittee has a team of dedicated Amateur Radio operators who are trained in communications and computer savvy members of the Computer Club can assist to find alternative Internet network providers that remain operational after an environmental catastrophe.

These are only a few of the resources available and NPT is reorganizing to create an active program that has the ability to minimize the impact of a disaster. NPT's reorganization includes holding elections for NPT officers. Elections will take place on November 16th at 10 a.m. in Desert Vista. Minimally the positions of President, Vice President, Secretary and Treasurer need to be filled, but hopefully others will also run to fill subcommittee positions.

"The mission of the Neighborhood Preparedness Team Community Organization shall be to foster education relating to all community residents' safety in responding to consequences of a natural, or industrial or criminal-related adversity, by means of a communitywide network, and to heighten consciousness of crime prevention techniques through a partnership with the Las Vegas Metropolitan Police Department. The community organization exists to benefit its members and shall operate as a nonprofit organization, with all funds being used for community organization purposes."



# **COMMUNITY STANDARDS** Did You Know????

evelopment Standards protections have basic rules in place to maintain the appearance of all lots. "Landscape Features," such as statues, fountains, "critters", and other personal niceties, are no exception.

For those who are "Students of the Standards", it is not a secret that no more than six landscape features in both the front and rear yards, is allowed. Del Webb Corporation liked orderly, pleasant, and compatible features when they wrote our rules, but let us know that, while they wanted us to express our individuality, they didn't like too much of a good thing. They also wanted the Eiffel Tower left on The Strip. so they limited the height of yard items to 48" from the grade level. When said another way, that means no 60" birdbaths on top of a 3-foot mound of stone, is allowed. And we're not through yet, because we have to keep plantings and décor at least 3' from the edge of sidewalks in the front yard, and we have to stick with earth-tone colors on items made only of stone or metal-no glass, no plastic, no wood! Live plants in decorative ceramic planting containers are allowed and are not considered part of the restricted items. Del Webb Corporation wanted us to look like the world-class community that we are, and they provided the guidelines for us to follow.

### Did You Know????

Trash containers do have a mind and a life of their own! They keep coming back at us, sort of like COVID-19. Our trash containers are only supposed to be visible on Monday afternoons and Tuesdays when they are out for pick-ups. Yet, they peek their heads out from their not so hidden places all too often.

Trash containers are not to be visible from the street, neighboring properties, or common areas. All too often, we are observing unsightly trash cans beside homes, partially hidden behind a bush, or anywhere else they seem to choose. There are many ways to solve this community issue. The easiest is to find room in the garage! If that doesn't work, we're glad to suggest some other reasonable storage alternates that will meet the Standards and get the job done. Moreover, it will save us tons of time writing violations. Remember, maximum trash container hours on the street are from 2:00 pm on Monday to midnight on Tuesday. Keep 'em out of sight, just like the trash stored in them!

### And, finally, Did You Know????

Sun City Summerlin prides itself in the appearance of its amenities and landscaping. So, once again we remind ourselves that our Development Standards are aimed at helping us to maintain residences and residential landscaping, as well.

As a result, there are certain "structures" that are prohibited in our front or back yards. Of particular note are sheds, other storage-type containers, wooden garden structures, lean-to's, wooden trellises, lattice panels, wooden support poles, etc., that are not allowed. Included in the restrictions are storage items made of plastic, vinyl and composite materials that also quickly deteriorate in the desert climate. The use of chicken wire, chain link fencing and other similar materials used for enclosing areas, are also not allowed.

Some structures on golf course lots, such as netting and netting support systems—because they protect residences from damage—will be considered on a case-by-case basis, upon submission of a written plan.

The primary goal of these restrictions is to protect common areas and adjacent residences from having to view unsightly structures, that can impact the value of surrounding properties.

# LIVE TREE POLICY

Official Notice to SCSCAI Owners of Policy Adopted at the August 09, 2022, Board of Directors Meeting

Sun City Summerlin Community Association, Inc. (Live Tree Policy & Live Tree Agreement Form)

After the Board adopts the Policy, the Policy must be sent to the Association's Membership within thirty (30) days after the mailing. (NRS 116.12065; NRS 116.31013 (4) (a)).

The Association's adoption of the Policy should hopefully deter the prohibited conduct, and further allow the Association to appropriately address such prohibited behavior.

Sun City Summerlin Community Association

Tree Policy Legal Authority-CC&R's Article X Section I

#### Live Tree Removal Policy

From time to time a live tree or trees may become an issue on the common areas owned or operated by the Association. In the case of a diseased or dead tree a homeowner should notify the Executive Director's office. This policy provides the procedure for a homeowner to request that a live tree, or trees, in any common area, inclusive of the golf course, be removed.

To request the removal of a tree the resident must complete a *Live Tree Removal Request and Agreement Form* and submit the completed form to the office of the Executive Director. The form is available on the SCSCAI web page and at the administrative offices. An incomplete form will be returned to the resident that requested the tree removal and no action will be taken until a completed form is received. The consideration for the removal of any tree from the common areas may include, without limitation, the following:

- 1. The tree is physically damaging property.
- 2. The tree is at risk for falling.
- 3. The tree has so developed that there is no longer sufficient clearance around the tree.
- 4. The tree, or landscaping around the tree, may not receive adequate water and/or sun.
- 5. The tree creates privacy or protection issues to the surrounding homes.
- 6. The tree blocks the views of neighboring properties.

After the completed Live Tree Removal Request and Agreement Form is received by the Executive Director, the form and any required back up information will be referred to the appropriate Department Director. If the request is for a live tree removal in the common areas it will be referred to the Director of Landscape Maintenance. If the request is for a live tree removal on the golf course it will be referred to the Director of Golf Course Maintenance. The office of the Executive Director will advise the neighboring property owners of the tree removal request. The neighboring property Owners will be offered an opportunity to comment on the request in writing.

The Executive Director and the appropriate Department Director will review the Live Tree Removal Request and Agreement Form, visit the location of the tree(s) and review the comments from the neighboring property Owners. If after this review, the Executive Director and Department Director agree that the tree or trees can be removed, a landscape improvement replacement plan will be developed for this area by the Department Director and submitted to the Architectural Review Committee. If the landscape improvement replacement plan is approved by the Architectural Review Committee, then the Owner requesting the tree(s) be removed will be notified of the total cost of the removal and the landscape improvement plan. The Owner will have sixty (60) days to submit payment in full for the removal of the tree(s) and the landscape improvement plan. If the payment is received the work will commence within thirty (30) days. If payment is not received the approval for the request is voided.

The homeowner will be advised of the decision of the *Live Tree Removal Committee* by the office of the Executive Director. If the request is denied, the homeowner will be advised that they may appeal the decision to the Board of Directors.

RESOLUTION OF THE BOARD OF DIRECTORS OF SUN CITY SUMMERLIN COMMUNITY ASSOCIATION, INC.

**BOARD COMMUNICATION POLICY 22.10** 

WHEREAS, the Board of Directors ("Board") of Sun City Summerlin Community Association, Inc. ("Association") is authorized under the Sun City Summerlin Declaration of Covenants, Conditions, Restrictions, Assessments, Charges, Servitudes, Liens, Reservation of Easements ("CC&Rs") recorded on January 9, 1989 in the Official Records of the Office of the County Recorder of Clark County, Nevada as Instrument No. 198901090000220 and the Third Completely Revised Edition of The Bylaws of the Sun City Summerlin Community Association, Inc. ("Bylaws") to promulgate rules and regulations and to enforce the Association's governing documents pursuant to NRS 116.3102, 116.31031, NRS 116.31065, and 116.4117; CC&R Article V Section 3; Bylaws § 6.1 (a) and;

WHEREAS, the Board of Directors has consulted with legal counsel retained to determine and confirm that its Board Communication Policy complies with Nevada law (NRS 116.001 et seq), and the Association's CC&Rs and;

WHEREAS, the Board of Directors has obtained the opinion of legal counsel that the adoption and imposition of rules proposed by this resolution outlining the Association's rules relating to Board member communications to the Executive Director and staff do not violate Nevada law and/or the Association's Governing Documents;

NOW, THEREFORE, IT IS HEREBY RESOLVED, that the Board of Directors of the Association adopts the following rules and regulations:

1. Statements, Remarks and/or Publications of the Association Must be Approved by a Majority of the Board or by the Executive Director: Any Association statement, remark and/or publication must be approved by a majority of the Board of Directors or the Executive Director. A single Board member is not entitled to make a statement, remark and/or publication on the Association's behalf. Any such statement, remark and/or publication may be removed by the Association without further notice. The approval of any statement, remark and/or publication shall be made in accordance with this Policy.

2. An Association Statement, Remark and/or Publication Does Not Trigger an Individual Board Member's Reciprocal Right: An Association Statement, Remark and/or Publication does not trigger a reciprocal right for an individual member of the Board in their capacity as a homeowner to make a statement, remark and/or publication utilizing an Association forum (e.g., website).

3. All Association Publications Utilizing an Association Website Must be Approved by a Majority of the Board or the Executive Director: A majority of the Board of Directors or the Executive Director must provide prior approval for any Association Publication that is made on an Association's Website. Individual members of the Board of Directors may not unilaterally make any publication on the Association's behalf. Any such unauthorized Publication shall be removed from the Association's website without further notice. The approval of any Association publication made pursuant to this section shall be made in accordance with this Policy.

4. The Executive Director May Reject or Refuse to Answer Certain Communications Once the Executive Director Has Consulted with an Officer of the Association. The Executive Director is hereby authorized to reject or refuse to answer or respond to any form of communication including without limitation, email(s), requests for meetings or phone calls from an Owner or Resident of Sun City Summerlin, including, without limitation, a member of the Board of Directors, if after consultation with an Officer of the Association, the Executive Director finds such communication to be harassing, bullying, repetitive, refusing to accept any answer already furnished by the Executive Director, or otherwise creating a hostile work environment. The Executive Director's authority to reject or refuse to answer certain communication as poly to proper requests from Owners under NRS 116.3108, 116.31087 or 116.31175. Once the Executive Director has consulted with an Officer of the Association as required herein, the Executive Director may reject or refuse to answer any subsequent communication (regarding the same topic or issue) from any such Board Member, Owner, or Resident without further consultation with an Officer of the Association.

5. The Executive Director is Authorized to Direct Association Staff Members to Reject or Refuse to Answer Certain Communications. The Executive Director is authorized to direct Association staff members to reject or refuse to answer or respond to any form of communication including, without limitation, email or emails, requests for a meeting, or phone call from an Owner or Resident of Sun City Summerlin, including, without limitation, a member of the Board of Directors, if after consultation with an Officer of the Association, the Executive Director finds such communication to Association staff to be harassing, bullying, repetitive, refusing to accept any answer already furnished by the Executive Director or Association staff, or otherwise creating a hostile work environment. The Executive Director's authority to direct Association staff to reject or refuse to answer certain communications shall not apply to proper requests under NRS 116.31083, 116.31087, or 116.31175.

6. The Executive Director and/or Association Staff Shall Not Be Subjected to Any Liability for Complying with the Terms of the Resolution. The Executive Director and Association staff of the Association shall have no liability to any person, including without limitation, any member of the Board of Directors for rejecting or refusing to answer, in accordance with the requirements contained in this Resolution, any communication from any Owner or Resident of Sun City Summerlin.

EFFECTIVE DATE, the secretary or another officer of the Association shall cause this Resolution to either be hand-delivered or mailed, via United States mail, to the mailing address of each unit or to any other mailing address designated in writing by the unit's owner within thirty (30) days of the date of execution below and/or electronically mailed to any electronic address provided for such notices. Said resolution shall be effective thirty (30) days after the date of such notice, which may be proven by a proof of mailing and/or delivery retained in the Association's records. However, the Board of Directors may begin adhering to this Policy for Board communications upon adoption, but no penalty for violation may apply until the expiration of thirty (30) day's notice.

THE RULES ESTABLISHED BY THIS RESOLUTION shall be effective and remain effective from the date set forth herein until such time as they may be amended, abolished, changed, or otherwise eliminated by the Association's Board of Directors.

INCORPORATION INTO OMNIBUS RULE DOCUMENT, subsequent to and in accordance with this Resolution, the Association may incorporate the rules and regulations established within this Resolution into a single, omnibus, document containing other rules and regulations for the Association. The language of the Resolution must be incorporated into such an omnibus document in the same manner as it is set forth herein. Incorporation of the language of this Resolution into an omnibus document shall be considered a courtesy or convenience to residents and shall in no way be construed to require the delivery or mailing of the omnibus rules to remain effective. The rules established by this Resolution shall be effective and remain effective from the date set forth herein until such time as they may be amended, abolished, changed, or otherwise eliminated by the Association's Board of Directors.

RESOLUTION TO CONFORM WITH NRS 116, this resolution was drafted in conformance with Nevada law, including, but not limited to, Chapter One-Hundred Sixteen of the Nevada Revised Statues, as of the date of execution of this document. Further, pursuant to this statement of conformance within this Resolution and NRS 116.1206, this Resolution and the Rules and Regulations established hereby shall be deemed and read to conform to an/or be superseded by Chapter One-Hundred Sixteen of the Nevada Revised Statues (NRS 116.001 *et seq.* and any future amendments to such Chapter and no amendment to this Resolution shall be necessary for such conformance.
